A number of specific projects raised by Individual Scientists or group of Scientists are being supported by different funding agencies such as CSIR, DAE, DNES, DST, DOS, DSIR, ICMR, INSA, NSF, UGC an UNDP. The institute under the present Director Prof Santanu Bhattacharyya leads in diverse dynamic programmes for the pursuit of research leading to the doctoral degree, post doctoral work along with visiting Scientists Scheme. There Institute is also equipped with a full fledged Library and up to date computerised environment.
