1. The Gujarat State AIDS Control Society (GSACS) is responsible for implementing the National AIDS Control Programme (NACP) Phase IV.

The Government of India has received a Credit (Credit-4299-IN) from the funds pooled by GFATM, POOL fund & D.B.S. Fund in various currencies towards the cost of Fourth National HIV/AIDS Control Project and it is intended that part of the proceeds of this credit will be applied to eligible payments under the contracts for which this invitation for Bids is issued. Gujarat SACS is a registered organisation under the control of the State Government and it the nodal organisation for all the HIV/AIDS prevention and control work that is taken up in the state. GSACS releases fund to peripheral organizations like NGOs and hospitals under the Government sector. Hence it is essential to assess as to conduct a Internal audit under the provision of the Societies Registration Act, 1860 as applicable in the State.

2.. Expressions of Interest are invited from CAG empanelled Chartered Accountant firms to conduct the Internal audit of the NGOs & Peripheral Units under GSACS for a financial year 2019-20.

Eligibility & Assessment Criteria:

The Eol and capability will be assessed against evidence of skills and experience in providing accountancy services in the State.

Requirements

The Eol should be sent along with a Capability Statement including a profile of the organisation relevant technical and coverage along with the geographical financial turnover for the last 3 financial years.
