REQUEST FOR PROPOSAL

Request for proposal is required from firms of Chartered Accountant practising in Allahabad to act as **Consultant on Goods and Service Tax Act** of Civil Aviation Training College, Allahabad as per **schedule** attached.

The requirement of Quotation:

- 1. Self attested copy of Certificate of Practice.
- 2. Self attested copy of Pan No of the Firm
- 3. Self attested copy of GST Registration No. of the Firm, if applicable.

General Scope of Works:

- 1. Compilation of GST data including review and verification, in the requisite format of Form GSTR-3B and GSTR-1 of CATC and CAT, Allahabad and any other format as notified by Govt. of India, from time to time and send to CATC, Allahabad within 3 days of receiving the GST report from CATC, Allahabad.
- 2. Reconciliation of ITC with GSTR 2.

Payment Terms:

- 1. The period of the agreement will be 2 years and can be extended by one more year, subject to satisfaction of the work and with mutual agreement.
- 2. If the work is not done to the satisfaction of CATC, the work may be rescinded with the approval of the competent authority.
- 3. If any penalty is imposed due to the fault of consultant, it shall be borne by the consultant.
- 4. The party will raise the bills on a quarterly basis for the services rendered.
- 5. Payment will be released within 15 days of submitting the bill and after deducting any TDS, if applicable, at the applicable rate, and after the completion of the work.
- 6. CATC will try to send the GST report to the consultant by 5 of the next month.
- 7. Payment would be made after due acceptance and deposit of tax, and acceptance of the report at the portal to be filed by SAU, Lucknow.

However, post selection of a consultant, if the scope of work increases than fees payable can be renegotiated. Please quote GST % and HSN code in the schedule.
