3. OTHER TERMS AND CONDITIONS

3.1.2. The competent authority of Bureau of Indian Standards, Hyderabad Branch Office, Telangana reserves the right to reject all or any bid in whole, or in part, without assigning any reason thereof.

3.1.3. After the opening of the administrative and technical bid, the attached documents will be checked. The evaluation of the tender will be done on the basis of the documents submitted. This is applicable to all bidders.

3.1.4. The bid of any bidder which has not met the eligibility criteria will be summarily rejected and bid(s) which do not comply with bid instruction and any conditions of the tender terms and conditions may also be rejected.

25. Preparation of Professional Tax statement of the employees every month in accordance with the **Telangana State notification** from time to time and assist the branch for timely payment of professional tax and filing of returns if required.
26. Preparation of statements, payments, filing of returns etc. of any other taxes levied by Govt. from time to time.

27. Assisting in furnishing the reply to all queries of internal Audit, CAG audit, GST, Professional Tax and Income Tax etc.
28. Providing opinion on the matters relating to GST, Professional Tax, and Income Tax as per Government notification from time to time.
29. Any other work assigned relating to accounts / statutory requirements etc.
30. One dedicated, B. Com/M. Com/CA graduates with well versed in Tally Software shall be deployed on all working days in the month. A senior professional member of the firm shall also visit the Branch every week to ensure that the work is being done as per norms/statutory requirements.

5. GENERAL CONDITIONS OF CONTRACT (GCC)

- 5.1. The CA firm should engage a citizen of India.
- 5.2. Manpower engaged should be trained for providing services according to the scope of work. whichever applicable and all other statutory payments will be the liabilities of the contractor, applicable from time to time.
- 5.6. BIS, Hyderabad shall have the right of removal of the person (employed by the contractor) who is not discharging his/her duties satisfactorily or his/her role is found dubious in nature.
- 5.7. The CA firm shall not engage any sub contractor or transfer the contract to another person/people/entity without prior permission of the competent authorities at BIS, Hyderabad.
- 5.9. The working duty will normally commence from 0900 AM to 0530 PM. But the timings are changeable and can be fixed by this office from time to time depending upon the requirements.
- 5.10. The changes in the personnel deployed will not be allowed without prior approval/permission of the BIS, Hyderabad or any other authorized officer.
- 5.11. No enhancement in the agreed rates will be allowed during the contract period except statutory revision, if any.
- 5.12. The performance bank guarantee shall be returned to the CA firm on the expiry of the contract period on furnishing usual clearance/No Demand Certificate. The performance bank guarantee shall be returned on the expiry (stated in the GeM bid document/portal) and termination of the contract subject to conditions that the CA firm has indemnified the 1st Party for all payments to the staff. The CA firm while requesting for release of the performance bank guarantee shall certify that all payments including labour laws obligations have been fulfilled and that the BIS, Hyderabad shall not be responsible for such payments to the staff arising out of the decision of the labour court, if any.

5.13. The contract shall come into force from the date of agreement signed by both the parties. In case the contractor fails to execute the job after signing the agreement deed or leave the job before completion of the period of contract at their own accord, the Bureau of Indian Standards, Hyderabad shall have the right to forfeit the performance bank guarantee deposited by the agency for execution of the contract.

5.14. In addition to existing criteria for selection, in case there is any tie in the rates, the documentary supports the period of experience for engagement of personnel in various Govt./Semi. Govt. offices and number of such personnel shall be given more weightage in selection.

5.15. Bureau of Indian Standards, Hyderabad Branch Office, Hyderabad, Telangana shall have the full power to terminate the tender process at any stage, without assigning any reason thereof. Bureau of Indian Standards, Hyderabad, Telangana decision in this regard will be the final.

5.16. The CA firm shall not engage in any such sub-bidder or transfer the contract to any other person in any manner.

5.17. All liabilities shall be borne by the CA firm that are arising out of accident or death while on duty.

5.18. BIS, Hyderabad campus shall not be liable for any damage or compensation payable in respect of or in consequence of any accident or injury to any workman or other person in the employment of the contract. The contractor shall indemnify and keep indemnified the BIS, Hyderabad against all such damage and compensation whatsoever in respect or in relation thereto.

5.19. The CA firm shall make its own arrangements for the transportation of its employees.

5.20. The CA firm staff will not be treated as the BIS, Hyderabad staff for any purpose whatsoever. BIS, Hyderabad Branch Office shall not be liable to any penalty under relevant rules, enactment, or related regulations for which the contractor is responsible under the law.

5.21. Force Majeure: At any time during the currency of the contract, either bidder is subject to force majeure, which can be termed as a civil disturbance, riots, strikes, tempest, acts of God, etc. which may prevent either party to discharge their obligation, the affected party shall promptly notify the other party about the happening of such an event. Neither party shall be entitled to terminate the contract in respect of such performance of their obligations. The obligations under the contract shall be resumed as soon as practicable after the event has come to an end or ceased to exist. The performance of any obligations under the contract shall be resumed as soon as practicable after the event has come to an end or ceased to exist. If the performance of any obligation under the contract is prevented or delayed by reason of the event beyond a period mutually agreed to if any or seven days, whichever is more, either party may at its option terminate the contract.

6. PENALTY CLAUSE

6.1. For any breach of contract, the Bureau of Indian Standards, Hyderabad Branch Office, Telangana shall be entitled to impose a penalty to the extent of Rs. 1,000/- on the 1st occasion upon the contractor in the event of breach, violation or contravention of any of the terms and conditions contained herein brought to the notice of the BIS, Hyderabad.

6.2. If the lapse is repeated again, the extent of penalty will be doubled on each such occasion. The decision of the said officer in this regard shall be final and binding upon the contractor. Some of the instances in which a penalty would be imposed, are enumerated below. But these are not exhaustive, and penalty may be imposed on any violation, breach or contravention of any of the terms and conditions as well as assigned duties and in following conditions: -

6.2.1. If the personnel are not found in approved, proper and clean uniform and/or not displaying a photo identity card.

6.2.2. If the personnel found indulging in smoking/drinking/sleeping during duty hours.

6.2.3. If the behaviour of personnel is found discourteous.

6.2.4. If any personnel found performing duty, found submitting fake names and addresses.

6.2.5. If persons other than the one mentioned in the approved list supplied by the agency, engaged for duty.

6.2.6. If any personnel found performing extended/ double duty within 24 hours without prior approval.

7. MANPOWER RELATED CLAUSE

7.1. Any misconduct/misbehaviour on the part of the manpower deployed by the Contractor will not be tolerated and such person will have to be replaced by the Contractor at his own costs, risks and responsibilities immediately, with written intimation to Bureau of Indian Standards, Hyderabad.

7.2. The CA firm shall employ adult employees only. Employment of child labour will lead to the termination of the contract. The CA firm shall be responsible for payment by following the Minimum wages Act as applicable and also by obeying all existing Labour laws.

8. TERMINATION CLAUSE

During the period of agreement if it is found that the agency is not providing proper services or charging by fraudulent manner or indulged in corrupt practices or disclose BIS, Hyderabad confidential information or other unprofessional behaviour, the entire performance bank guarantee, deposited with Bureau of Indian Standards, Hyderabad Branch Office, Telangana or part thereof shall be forfeited in favour of BIS, Hyderabad and agreement will be terminated after giving 30 days' notice.

9. ARBITRATION

9.1. In the event of any question, dispute/ difference arising under the agreement or in connection herewith (except as to matter the decision of which is specially provided under this agreement) the same shall be referred to the sole arbitration by the Bureau of Indian Standards, Hyderabad Branch office, Hyderabad or his/her nominee.

9.2. The award of the arbitrator shall be final and binding on the parties. In the event of such arbitrator to whom the matter is originally referred is being transferred or vacating his office or resigning or refusing to work or neglecting his work or being unable to act for any reason whatsoever, the Sc-E/Director & Head, Bureau of Indian Standards, Hyderabad Branch Office, Hyderabad, Telangana campus shall appoint another person to act as Arbitrator in place of the out-going Arbitrator in accordance with the terms of this agreement and the person so appointed shall be entitled to proceed with the reference from the stage at which it was left by his predecessor.

9.3. The Arbitrator may give interim award(s) and/or directions, as may be required.

9.4. Subject to the aforesaid provisions, the Arbitration & Conciliation Act, 1996 and the rules made thereunder and any modification thereof from time to time being in force shall be deemed to apply to the arbitration proceedings under this clause.

9.5. Any arbitration will be under the jurisdiction of Telangana state authorities only.

10. JURISDICTION

The contract shall be governed by and construed according to the law in force in India.

The bidder shall hereby submit to the jurisdiction of the courts situated at Telangana for the purpose of actions of any proceedings arising out of the contract, and the courts at Telangana only will have the jurisdiction to hear and decide such actions and proceedings.
