1. **DEFINITIONS**

- 2.2 The Bidder should have an average annual turnover (audited) **of INR 100 lakhs or more** in last three financial years i.e. 2019-2020, 2020-21 and 2021-2022 as per latest audited financial statement. This turnover of the firm should be supported by audited balance sheet or certified annual report.
- 2.3 The bidder should have an experience of providing direct taxation services to at least 2 clients having turnover of more than Rs. 100 lakhs and expertise to provide direct/indirect taxes, etc. to any Government or Public Sector Organisation.
- 2.4 The 2 key team members deployed on the project must be employed by the bidder and its group firm who should have a professional degree i.e.CA/CS should have relevant experience of 10 years in the indirect taxation. The team combination/constitution shall be as per following:-
 - 1. Expertise of the 1 Key team members in the field of direct taxation of more than 5 years.
 - 2. Expertise of the 1 Key team members of more than 10 years in the field of direct taxation.
- 2.5 The bidder firm/ should have a valid GST & Profession Tax Registration certificate. Copy of same to be attached as proof.
- 2.6 Team members of the bidder firm should have a knowledge of Marathi language.
- 2.7 The bidder firm should have their own Office equipments (Viz. Computer / Laptops, etc.) and Stationaries.

3 SCOPE OF WORK AND DELIVERABLES:

The indicative scope of work in connection with *Income Tax*, as per The Income Tax Act, 1961 and for *Profession Tax*, as per The Profession Tax Act, 1975. For details refer **Section–10** (Scope of work).

TIMELINES: The entire assignment has to be completed as per time specified. The continuation and duration of the tasks will be at the sole discretion of The Brihanmumbai Municipal Corporation(BMC). The Brihanmumbai Municipal Corporation(BMC) may decide to alter the timelines for any of the task stated above and consequently the payment schedule will also be revised accordingly.

4 PAYMENT TERMS:

The terms of payment will be as under:

- Payment will be made on the **quarterly** basis (for 37 months+GST as applicable)
- Though the quarterly offer of the consultant is to be accepted, payment will be
 made only on the basis of satisfactory completion of individual work as defined

- No work order shall exceed over the total sanctioned contract cost.
- Work order for specific work will be issued to the consultant and payment will be released accordingly.

5 COST OF BIDDING:

3. In case of Equal Percentage of lowest bidders (L1), the allotment of work shall be done by giving 48 hrs. (2 working days) from the day of opening of packet C on same BID-Document number for re-quoting and such development needs to done by IT department in The Brihanmumbai Municipal Corporation(BMC)'s SRM system. Till such development is made; 'Sealed Bids' shall be called from the bidders quoting the same rates i.e. L1.

D. BID PRICES - C Packet:

8. Online financial offer

9 PERIOD OF VALIDITY OF BIDS:

- 10.2 Documents to be uploaded: Original scanned document (or photocopies of specific documents mentioned in respective tender schedule copy got attested from Gazette Officer of the State / Central Government or from the officer of Brihanmumbai Municipal Corporation (BMC) not below the rank of Assistant Engineer / Administrative Officer / Account Officer before uploading the same in Packet A).
- 10.3 Procedure for the opening of the tender folder: Packet A Technical Bid (i.e. PacketA/B) will be opened online on the due date and due time as stated in the Tender Notice / corrigendum if any when the tenderer or his authorized representative will be allowed to remain present. Packet C-Financial Bid (i.e. Packet C) will be opened only if the Technical offer in Packet A is acceptable. In case the Technical Bid in Packet A is found not acceptable or found incomplete, the Packet C will not be opened and offer will be kept out of consideration.

The date and time of the opening of Packet C will be intimated to the respective tenderer well in advance.

F. BID OPENING AND EVALUATION:

- 11. 1 Brihanmumbai Muncipal Corporation(BMC) shall open technical bids in the presence of bidders or their authorized representatives who chose to attend, at 11.00 am hrs on due date. The bidder's representatives, who are present shall sign in an attendance register. Authority Letter to this effect shall be submitted by the bidders before they are allowed to participate in bid opening.
- 11.2 A maximum of Two representatives of any bidder shall be authorized and permitted to attend the bid opening.

12. PRELIMINARY EVALUATION:

- 12.1 Brihanmumbai Muncipal Corporation(BMC) shall evaluate the bids to determine whether they are complete in all respects, whether the documents have been properly signed and whether the bids are generally in order.
- 12.2 Prior to the detailed evaluation, Brihanmumbai Muncipal Corporation(BMC) will determine the substantial responsiveness of each bid to the bid document. For purposes of these clauses, a substantially responsive bid is one which confirms to all the terms and conditions of the Bid Documents without material deviations. Brihanmumbai Muncipal Corporation(BMC) determination of bid's responsiveness shall be based on the contents of the bid itself without recourse to extrinsic evidence.
- 12.3 A bid, determined as substantially non-responsive will be rejected by the Brihanmumbai Muncipal Corporation(BMC) and shall not subsequent to the bid opening be made responsive by the bidder by correction of the non-conformity.

- 12.4 Brihanmumbai Muncipal Corporation(BMC) may waive any minor infirmity or non-conform ity or irregularity in a bid which doesn't constitute a material deviation, provided such waiver doesn't prejudice or effect the relative ranking of any bidder. The decision of the Brihanmum bai Muncipal Corporation(BMC) shall be final.
- 12.5 Arithmetical errors shall be rectified on the following basis. If there is a discrepancy between words and figures, the amount in words shall prevail. If a bidder does not accept the correction of the errors, its bid will be rejected.

13. EVALUATION AND COMPARISON OF SUBSTANTIALLY RESPONSIVE BIDS:

- 13.1 The Brihanmumbai Municipal Corporation(BMC) shall evaluate in detail and compare the bids previously determined to be substantially responsive, for technical compliance.
- 13.2 All the offers, found technically suitable shall be intimated, in writing, of the date of opening of the financial bid. The bidders may attend the opening of bids.

14. CONTACTING THE BRIHANMUMBAI MUNICIPAL CORPORATION(BMC):

- 14.1 No bidder shall try to influence The Brihanmumbai Municipal Corporation(BMC) on any matter relating to its bid, from the time of the bid opening till the time the contract is awarded.
- 14.2 Any effort by a bidder to modify his bid or influence The Brihanmumbai Municipal Corpora tion(BMC) in The Brihanmumbai Municipal Corporation(BMC)'s bid evaluation, bid comparison or contract award decision shall result in the rejection of the bid.

G AWARD OF CONTRACT:

15 AWARD OF WORK:

- 15.1 The Brihanmumbai Municipal Corporation(BMC) shall consider for award of work only those eligible bidders whose offers have been found technically, commercially and financially accepatable and whose services offered are is as per e-tender specifications and the award will be made only on the basis of evaluation of bids, to the lowest quoted bidder, out of such technically eligible bidders.
- 15.2 The Brihanmumbai Municipal Corporation(BMC) is not found to accept the lowest or any Bid and reserves to itself the right to accept or reject the whole or any part of the Bid the bidders shall deliver the services as decided by The Brihanmumbai Municipal Corporation(BMC) at the approved rates.

Work order shall be issued for entire contract. If performance of bidder is not satisfactory during the various phases The Brihanmumbai Municipal Corporation(BMC) reserves the rights to cancel the incomplete task of further phases. The bidder will not approach the court against the decision of The Brihanmumbai Municipal Corporation(BMC) in this regard.

16 LETTER OF INTENT/LETTER OF AWARD OF WORK (LOA):

- The letter of intent shall constitute the intention of The Brihanmumbai Municipal Corpora tion(BMC) to issue a letter of award of work to the successful bidder(s).
- 16.2 The bidder shall, within 7 days of the issue of the LOA, communicate his acceptance in writ ing.
- 16.3 Failure to comply with the requirement of clause 16.2 shall constitute sufficient ground.

For the annulment of the acceptance of the bid and in which event The Brihanmumbai Munic ipal Corporation(BMC) shall feel free to issue a letter of award of work to other bidder(s) or call for fresh bids.

17 SIGNING OF CONTRACT:

The issue of letter of award of work shall constitute the award of contract on the bidder.

18 RIGHT TO CANCEL THE CONTRACT:

The Brihanmumbai Municipal Corporation(BMC) shall have right to cancel the contract wholly in the event of any decline, diminution, curtailment or stoppage of the work(s). In that event, this will be mutually discussed and settled depending upon the status of the contract and decision of The Brihanmumbai Municipal Corporation(BMC) shall be binding upon the bidder.

19 NON PERFORMANCE:

- 19.1 The Brihanmumbai Municipal Corporation(BMC) reserves the right to disqualify the bidder for a suitable period who has failed or fails to undertake the job in accordance with the time lines agreed to and also during the course of the performance does not produce the results required and expected as per the contract terms and conditions deliver on time.
- 19.2 The Brihanmumbai Municipal Corporation(BMC) reserves the right to blacklist a bidder for a suitable period in case he fails to honour his bid without sufficient grounds.

GENERAL (COMMERCIAL) CONDITIONS OF CONTRACT

1. APPLICATION

The general condition shall apply in contracts made by The Brihanmumbai Municipal Corporation (BMC) for the delivery of services.

2. CONFIDENTIALITY

The bidder, including all personnel shall not disclose, divulge, share, discuss, lend, licence or sell to any third party any information, data, databases, documents, software, proprietary information, tax-payer information or technical material ("information") supplied to or by The Brihanmumbai Municipal Corporation(BMC) in the performance of the Agreement.

3. EXCLUSIVITY

The Agreement shall not restrict The Brihanmumbai Municipal Corporation(BMC) from contracting for identical or similar services from any other person.

4. DISCLAIMER

MCGM shall not be liable for any inaccuracies in the E-Tender & its sections. The Brihanmumbai Municipal Corporation(BMC) has provided its best efforts to give the details according to its best knowledge and experience. If any details changes, The Brihanmumbai Municipal Corporation(BMC) shall provide notice so that the proposals may be altered accordingly.

5. PERSONNEL

- 1. All parts of the services(s) shall be performed by persons qualified and skilled in performing such services.
- 2. The Bidder shall replace any of its personnel if they are unacceptable to The Brihanmumbai Municipal Corporation(BMC) because of security risk, incompetence, conflict of interest and breach of confidentiality or improper conduct upon receiving written notice from The Brihan mumbai Municipal Corporation(BMC).
- 3. The Bidder shall pay the wages and benefits of any personnel. Nothing contained or implied in any forthcoming Agreement shall create any contractual relationship between the bidder's personnel and The Brihanmumbai Municipal Corporation(BMC)
- 4. The Brihanmumbai Municipal Corporation(BMC) shall not be liable for any loss, damage, theft, burglary or robbery of any personal belongings, equipment or vehicles of the personnel, agents of the Bidder.

6. INTELLECTUAL PROPERTY

- 1. All documents, raw data, research, processes, technology, film, artwork, engravings, dies, paper tapes, magnetic media, programs, designs and inventions (collectively referred to as the "information") conceived of, collected, completed or produced in the course of performance of the contract by the Bidder, (including all Personnel) for The Brihanmumbai Municipal Corporation(BMC) or provided to the Bidder by The Brihanmumbai Municipal Corporation(BMC) shall be the exclusive property of The Brihanmumbai Municipal Corporation(BMC) and shall be kept confidential.
- 2. The Bidder shall not disclose any information or report related to this assignment to any person or group of persons without the written direction of The Brihanmumbai Municipal Corporation(BMC).
- 3. The Bidder shall not retain any information related to the Assignment, in any medium, and shall return all copies.
- 4. All information and documents supplied to the Bidder under the Agreement and all reports, programs, procedures, documents and information produced under the Agreement are the property of The Brihanmumbai Municipal Corporation(BMC) and shall be returned upon completion of contract.
- 5. All materials prepared at the request of and for The Brihanmumbai Municipal Corporation(BMC) shall remain the property of The Brihanmumbai Municipal Corporation(BMC) except with the written consent.

PAYMENT TERMS

- 7.1 Payment will be done on satisfactory completion of scope of work as defined in Section 10 of the e-tender document.
- 7.2 All payments will be made in Indian Rupees only
- **7.3** No payment shall be made for non-satisfactory services provided which is w/o prejudice to The Brihanmumbai Municipal Corporation(BMC)'s right to resort to other punitive measures.

Note: GST and other state levies/cess which are not subsumed under GST will be applicable. The tenderer shall quote inclusive of all taxes applicable at the time of bid submission. It is clearly understood that BMC will not bear any additional liability towards payment of any Taxes & Duties. Wherever the services to be provided by the Tenderers, falls under Reverse Charge Mechanism, the price quoted shall be exclusive of GST, but inclusive of taxes/Duties/Cess otherthan GST, if any.

Rates accepted by BMC shall hold good till completion of work and no additional individual claim shall be admissible on account of fluctuations in market rates; increase in taxes/any other levies/tolls,etc. Except that payment/recovery for overall market situation shall be made as per price variation and if there is any subsequent change (after submission of bid) in rate of GST applicable on the work/services to be executed as per tender, i.e.any increase will be reim bursed by BMC whereas any reduction in the rate of GST shall be passed on to BMC as per the provisions of the GST Act.

9. DELAYS IN THE SUPPLIER'S PERFORMANCE

- 9.1 Deliveries and performance of the services shall be made by the bidder in accordance with the time schedule specified in the Letter of Intent (LOI)/Letter of Award of work (LOA). In case the deliveries of services are not completed in the stipulated delivery period, as indicated in the LOI/LOA, The Brihanmumbai Municipal Corporation (BMC) reserves the right to cancel the said LOA and/or take recourse to the other provisions of the contract. The cancellation of the or der shall be at the risk and responsibility of the bidder and The Brihanmumbai Municipal Corpo ration(BMC) reserves the right to get the balance work completed at the risk and cost of the de faulting vendors.
- 9.2 If at any time during the performance of the contract, the bidder encounters condition impending timely delivery of the goods and performance of service, the bidder shall promptly notify to The Brihanmumbai Municipal Corporation(BMC) in writing the fact of delay, its likely duration and its cause(s). As soon as practicable after receipt of the bidder's notice, The Brihanmumbai Municipal Corporation(BMC) shall evaluate the situation and may at its discretion extend the period of performance of the contract.

10 FORCE MAJEURE

If, at any time, during the continuance of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reasons of any war or hostility, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts or act of God (hereinafter referred to as events) provided notice of happenings of any such eventuality is given by either party to the other within 21 days from the date of occurrence thereof, neither party shall by reason of such event be entitled to ter minate this contract nor shall either party have any claim for damages against other in respect of such non-performance or delay in performance, and deliveries under the contract shall be resumed as soon as practicable after such an event come to an end or cease to exist, and the decision of The Brihanmumbai Municipal Corporation(BMC) as to whether the deliveries have been so resumed or not shall be final and conclusive. Further, that if the performance in whole or part of any obligation under this contract is prevented or delayed by reasons of any such event for a period ex ceeding 60 days, either party may, at its option, terminate the contract.

11 TERMINATION FOR DEFAULT

- 11.1 The Brihanmumbai Municipal Corporation(BMC) may, without prejudice to any other remedy for breach of contract, by written notice of default, sent to the Bidder, terminate this contract in whole or in part.
- (i) If the Bidder fails to deliver services within the time period(s) specified in the contract, or any extension thereof granted by The Brihanmumbai Municipal Corporation(BMC) pursuant to clause 9.

- (ii) If the Bidder fails to perform any other obligation(s) under the Contract; and If the Bidder, in either of the above circumstances, does not remedy his failure within a period of 15 days (or such longer period as The Brihanmumbai Municipal Corporation(BMC) may authorize in writing) after receipt of the default notice from The Brihanmumbai Municipal Corporation(BMC).
- In the event The Brihanmumbai Municipal Corporation(BMC) terminates the contract in whole or in part pursuant to clause 9 above The Brihanmumbai Municipal Corporation(BMC) may arrange to get procure, upon such terms and in such manner as it deems appropriate, same services or similar to or akin to the same services to those are not performed undelivered and the Bidder shall be liable to The Brihanmumbai Municipal Corporation(BMC) for any excess cost for such or similar services. However the Bidder shall continue the performance of the contract to the extent not terminated.

12 TERMINATION FOR INSOLVENCY

The Brihanmumbai Municipal Corporation(BMC) may at any time terminate the Contract by giving written notice to the Bidder, without compensation to the Bidder. If the Bidder becomes bankrupt or otherwise insolvent as declared by the competent court provided that such termination will not preju dice or affect any right of action or remedy which has accrued or will accrue thereafter to The Brihan mumbai Municipal Corporation(BMC).

13 CONTRACT DEPOSIT

The successful tenderer here after referred to as a consultant shall pay an amount of 2% of contract de posit in the form of Banker's guarantee from the Banker's approved by The Brihanmumbai Municipal Corporation(BMC) & Bankers Guarantee should be valid even after 6 months of the expiry of the con tract period and shall be paid within 30 days from the date of issue of letter of acceptance.

The Banker's Guarantee for contract deposit will not be accepted in broken period and same will be one completed Bank Guarantee for entire contract period + six months.

The Banker's Guarantee issued by branches of approved Banks beyond Kaylan and Virar can be ac cepted only if the said Banker's Guarantee is countersigned by the Manager of a Branch of the same bank, within the Mumbai City limit categorically endorsing thereon, that, the said Banker's Guarantee is binding on the endorsing Branch of the Bank within Mumbai limits and is liable to be enforced against the said Branch of the Bank in case of Default by the contractor/supplier furnishing the banker's guarantee.

14 REFUND OF CONTRACT DEPOSIT

Contract deposit will be refunded after 6 months after satisfactory completion of contract period.

15 BID SECURITY EMD

- The Bidder shall furnish, as part of the Bid, Bid Security/EMD, in the amount specified in the Bid Data Sheet. This bid security shall be in favor of the authority mentioned in the Bid Data Sheet and shall be valid till the validity of the bid.
- The consultants shall pay the EMD online.
- Any bid not accompanied by an acceptable Bid Security and not secured as indicated in sub-clause mentioned above, shall be rejected by the Employer as non-responsive.
- The Bid Security of the successful Bidder will be discharged when the Bidder has signed the Agreement and furnished the required Security Deposits.

- The Bid Security/ EMD and ASD of L-2 and other higher bidders (L-3, L-4,etc.) shall be refunded immediately after opening of financial bid.
- In case, the successful bidder become non-responsive or successful bidder, in such circumstances, if L-2 bidder is
 agreeable to extend the bid validity period and ready to deposit the requisite amount of bid security/EMD and
 ASD to the department within the stipulated time period i.e. 15 days, the department will process further as per
 normal procedure.

The Bid Security may be forfeited:

- a) If the Bidder withdraws the Bid after bid opening (opening of technical qualification part of the bid during the period of Bid validity;
- b) In the case of a successful Bidder, if the Bidder fails within the specified time limit to:

GRIEVANCE REDRESSAL MECHANISM

The Brihanmumbai Municipal Corporation(BMC) has formed a Grievance Redressal Mechanism for redressal of bidder's grievances. Any Bidder or prospective Bidder aggrieved by any decision, action or omission of the procuring entity being contrary to the provisions of the tender or any rules or guidelines issued therein. In packet 'A', 'B' & 'C' can make an application for review of decision of responsiveness in Packet 'A', 'B' & 'C' within a period of 7 days or any such other period, as may be specified in the Bid document.

While making such as application to procuring entity for review, aggrieved bidders or prospective bidders shall clearly specify the ground or grounds in respect of which he fees aggrieved.

Provided that after declaration of bidder as a successful in Packet 'A' (General Requirements), an application for review may be filed only by a bidder who has participated in procurement proceedings and after declaration of successful bidder in Packet 'B' (Technical Bid), an application for review may be filed only by successful bidders of Packet 'A'. Provided further that, an application for review of the financial bid can be submitted, by the bidder whose technical bid is found to be acceptable / responsive.

Upon receipt of such application for review, The Brihanmumbai Municipal Corporation (BMC) may decide whether the bid process is required to be suspended pending disposal of such review. Grievance Redressal Committee (GRC) is headed by concerned D.M.C./Director of particular department for the first appeal/grievances by the bidder against the decision for responsiveness / non-responsiveness in Packet 'A', Packet 'B' or Packet 'C' and if not satisfied, concerned A.M.C. will take decision as per second appeal made by the bidder.

This Grievance Redressal Committee (GRC) will be operated through DMC(CPD) office where appeals of aggrieved bidder will be received with fee of Rs.25,000/- from aggrieved bidder. The necessary correspondence in respect of said applications to the aggrieved bidder & concerned department, issuing notices, arranging of Grievance Redressal Committee(GRC) with D.M.C. and further proceeding will be carried out through registrar appointed by The Brihanmumbai Municipal Corporation(BMC).

No application shall be maintainable before the redressal Committee in regard of any decision of the BMC relating to following issues :

Determination of need of procurement

The decision of whether or not to enter into negotiations

Cancellation of a procurement process for certain reasons

On receipt of recommendation of the Committee, It will be communicate his decision thereon to the Applicant within 10 days or such further time not exceeding 20 days, as may be considered necessary from the date of receipt of the recommendation and in case of non-acceptance of any recommendation, the reason of such non-acceptance shall also be mentioned in such communication.

Additional Municipal Commissioner and/or Grievance Redressal Committee, if found, come to the conclusion that any such complaint or review is of vexatious, frivolous or malicious nature and submitted with the intention of delaying or defeating any procurement or causing loss to the procurring entity or any other bidder, then such complainant shall be punished with fine, which may extend to Five Lac Rupees or two percent of the value of the procurement, whichever is higher.
