  - Validation of all the PAN and challans in order to ensure an error free TDS return.
  - c. Generation of Form 27A and submission of TDS returns as per the provisions of the Income Tax act, 1961.
  - Generating and sharing TDS certificates in Form 16A (non-salary) and Form 16 (salary) with ESIC, as per the provisions and within the timelines provided under the Income Tax Act, 1961.
