GENERAL TERMS AND CONDITIONS OF CONTRACT AND TERMS OF SERVICE

Earnest Money Deposit:

- 1. An Earnest Money Deposit (EMD) in the form of a demand draft/ BC for Rs. 3,000 (Rs. Three thousand only) drawn on any nationalized / scheduled Bank in favour of "Agrinnovate India Limited" payable at New Delhi only. EMD in any other form will not be accepted and shall be deposited with the Company latest by 10.03.2021, 02.00 PM i.e. tender closing date and time. The particulars of the earnest money deposited must also be mentioned on the top of the envelope by indicating the draft/Banker's Cheque number and date.
- 2. The earnest money will be forfeited:
 - a. If the Tenderer withdraws his Tender during the period of Tender validity or modify the conditions thereof.
 - b. If in the case of the successful Tenderer, the Tenderer fails to sign the contract or to furnish performance security in accordance with general terms and conditions of contract.
- 3. Return/refund of EMD to the unsuccessful/non-responsive Tenderer(s) will be made normally within 90 days after the successful award of tender. No interest shall be payable on it under any circumstances.
- 4. Return/refund of EMD to successful bidder will be made within 90 days after signing of contract and deposit of performance security.

Performance Guarantee:

- 1. The successful Tenderer shall be required to furnish a performance security of Rs.10,000 (Rupees ten thousand only) as security deposit in favour of Agrinnovate India Limited within fifteen days after receipt of Award Letter in the form of a Demand draft/ Bank guarantee/FDR from a nationalized / scheduled bank in favour of "Agrinnovate India Limited" payable at New Delhi. No interest will be payable on the performance security.
- 2. The performance guarantee in the form of a bank guarantee shall be discharged / returned on expiry and successful completion of the contract, within a period of 60 days. In case of non-execution of the contract/poor services, in part or in full, the performance security shall be forfeited, after giving due notice to the Contractor in respect of the defective / improper performance / execution or breach of any of the terms of the contract etc.

- 3. Any sum of money due or payable to the Contractor, including the performance security refundable to him under the contract, may be apportioned by Agrinnovate, against any amount of loss caused / penalty imposed on the Contractor, which the Contractor may owe to Agrinnovate under this contract or any other contract or transaction.
- 4. If tenderer does not accept the offer, after issue of letter of award by Agrinnovate India Limited within 7 days, the offer made shall be deemed withdrawn & Earnest money shall be forfeited.

Scope of Work:

- 1. Timely filing of Quarterly TDS return as per Income Tax Rules.
- 2. Timely Filing of Annual Income Tax Return.
- 3. Timely Filing of Goods Service Tax Return as per Goods Service Tax Rules.
- 4. Timely filing of TDS on Goods Service Tax Return as per Goods Service Tax Rules.
- 5. To get assessment order from Income Tax Department on receipt of any notice from Income Tax Department.
- 6. To give suggestion for improvement to maintain the accounts book of the Company in conformity with different tax laws.
- 7. Examination of applicability of various provision of Income Tax Act 1961 GST Rules with respect to organisation.
- 8. Attending the meeting with Income Tax/Goods Service Tax Department on behalf of Agrinnovate India Limited personally regarding any notice issued by the Income Tax/Goods Service Tax Authority. Reply to these Authorities as and when required.
- Goods Service Tax, Input Credit and Cenvat related works and to verify and certify
 the monthly /periodical adjustments / claims for availing of GST/ CENVAT credit by
 Agrinnovate India Limited as per prevailing Goods Service Tax Rules and CENVAT
 credit Rules.
- 10. Checking of Advance Tax calculation as per Income Tax Act with reference to Company books.
- 11. Income Tax calculation of the Agrinnovate India Limited employees and checking of the documents submitted by the employees submitted for tax exemption.
- 12. Issue of all statutory forms such as Form 16, 16A, 24Q, 26Q etc.
- 13. Quarterly calculation of TDS receivables and interest accrued on FDs of the Company through 26AS.

14. Any clarification and advice in taxation/ statutory matters as and when required by the Company.

Terms of Reference:

The award of contract will be governed by the following terms and conditions:

- 1. The Firm should quote their rate in Lump Sum excluding Goods Service Tax for appointment as Tax Consultant of the Company in Annexure-II
- 2. The quotation should be given/giving address, telephone number and E-mail address, other relevant details with relevant supporting documents duly signed by authorized signatory.
- 3. Copy of PAN/TAN No. etc. (as required) of the agency should be attached with quotation.
- 4. The bidders may visit the Company office to examine the financial statements, reports and related documents for assessment of work involved during office hours on working days, if so desired.
- 5. The tenders shall remain valid for 90 days from the date of opening of quotation(s).
- 6. The tender document should be kept intact.
- 7. The sealed bid should be submitted at Company office with duly signed and stamped documents as mentioned in the Annexure-II. Any bids submitted in open at Company Office will be summarily rejected.
- 8. The Company reserves the right without assigning any reason to accept or reject any/all quotation(s) in whole or in part.

Extension and Termination of Contract:

- 1. The contract will be initially valid for a period of one year from 01.04.2021 to 31.03.2022. The period of contract is extendable by another two years subject to rendering of satisfactory services by the firm & mutual consent of both the parties on the same terms & conditions. However, it shall be with the consent / written request by the CA firm in this regard.
- 2. The contract may be terminated by this office at any time without assigning any reason, if the work of the firm is not found satisfactory. In this connection, the decision of the Company shall be final and binding on the firm.

Payment Terms:

- 1. The rates should be quoted for the whole year (exclusive of taxes). Payment will be made in four instalments at the end of each quarter subject to satisfactory services.
- Company will pay taxes as per Government of India norms applicable from time to time.
- 3. Payment to the selected CA firm will be made on quarterly basis.
- 4. No advance payment will be made by the Company. The approved firm shall submit the bill at the end of each quarter.
- 5. Income Tax/TDS as per rule shall be deducted from the bill.

Settlement of Disputes:

- 1. Chief Executive Officer, Agrinnovate India Limited reserves the right to reduce or terminate the period of contract or to extend its duration in the interest of the Company, for any justifiable reasons, not mandatory to be communicated to the tenderer.
- 2. Decision of Chief Executive Officer, Agrinnovate India Limited will be final for any aspect of the contract and binding to all parties.
- 3. In case of any dispute, the jurisdiction shall be Delhi Court.

Evaluation Criteria and Award of Contract:

- 1. The contract will be awarded to the bidder who will quote the lowest rates in the sealed quotation.
- 2. Acceptance of the offer will be communicated by email/ fax/ letter or any other form of communication. Formal letter of acceptance and work order of the Tenders will be forwarded as soon as possible, but the earlier instructions in the email/ fax / letter should be acted upon immediately.
- 3. If tenderer does not accept the offer, after issue of letter of award by Agrinnovate India Limited within 15 days, the offer made shall stand withdrawn.
