Terms and Conditions:

(i) The following terms and conditions may be applied in tender document:

- The contract period will be for three year effective from 01.02.2024 onwards. However, the contract is extendable on the recommendation of TEFC of CCS HAU, Hisar with the permissic 1. of the Vice-Chancellor subject to satisfactory performance provided by the agency / contractc The performance of the agency/contractor will be reviewed after every year by the Performanc Review Committee to be constituted by the Competent Authority.
- The University will have right to hire all above mentioned services OR any of the above servic 2. on need basis.
- FCA will be responsible for issuance of Form-16 to all University employees, timely filing o 3. Income Tax TDS Returns and Income Tax Returns (Monthly/ Quarterly/Half yearly/Annual) and another specified work in tender as per rule.
- The agency/contractor will have to deposit tender document fee of Rs. 1000/- in the shape of 4. online payment inclusive tender form cost (Non-refundable). The cost of e-tendering worth Rs. 1180/- will be borne by the agency/ contractor himself.
- The firm must have 05 years old registration with ICAI and at least three years' experience of 5. working with Govt. Universities /Govt. Organizations/ Govt. Institutions and Govt. Companies/Boards/Corporations/PSU.
- Contractors/Bidder are required to confirm and declare that no agent, middleman or any 6. intermediary will be engaged to provide service. If the "University" subsequently finds to the contrary, it reserves the right to declare the Contractor as non-compliant and declare any contract if already awarded, to be null and void.
- The tender documents containing technical bid, financial bid, term & conditions etc. can be 7 downloaded from the University website. The EMD of Rs. 75,000/- through online transfer (NEFT/ RTGS) will be required to be deposited by all the tenderers with the technical bid. However, the EMD will be retained by the University in respect of only that agency/contractor who has been awarded contract. EMD of unsuccessful bidders / tenderers will be returned within a week after finalization of contract. The EMD amount Rs. 75,000/- deposited by successful bidder will be refunded after receipt of security deposit in form of Bank FDR of Rs. 75,000/under bank lien of Comptroller, CCSHAU, Hisar. The Security Deposit shall be refundable after six months of successful completion of contract period and submission of No Dues from all Controlling Officers.
- The firm must have annual turnover of atleast Rs.50 lakh during preceding three financial years. 8
- 9 The firm should not be debarred from ICAI or RBI or any other statutory body for any misconduct in the last five years.
- 10 The firm will provide technical staff who will sit in the office of Comptroller and will collect data/information from the University and ensure the filing of returns in time.
- Acknowledgement of filling return will be provided by the University for record. 11
- Financial bid will be opened only for those agencies/ contractors who qualify in the technical 12 evaluation by the Tender Evaluation and Finalization Committee (TEFC) on the prescribed date.
- The employees of this University and their family members shall not be permitted to submit the 13 tender. If such case is observed the Bid is liable for rejection.

- 15 The contract can be further extended on the basis of satisfactory work/performance as per requirement of the university.
- 16 The agency/contractor shall have to provide relevant record during the period of contract whenever required by the University.
- 17. Selected CA Firm will have to give an Undertaking that he will maintain confidentiality and determination about the University's information & FCA will not share information with any other person/organization.
- 18. One hard copy of Form-16 set, Income Tax with bill be provided as per the standards prescribed by Got. Of India by the FCA to the University for record free of cost.
- 19. Payment will be made after completion of individual service/work <u>on monthly</u> bill basis. TDS will be deducted from the bill/bills at source as applicable from time to time.
- 20. University will not pay any other charges like munsiana, typing etc. or any other out of pocket expenses However, Departmental Fee/ Charges, (if any) will be paid by the University.
- 21. The right of acceptance of the tenders/ other bids will rest with the Vice-Chancellor of the University and it is not binding for Chaudhary Charan Singh Haryana Agriculture University, Hisar to accept the lowest tender. However, the University reserves the rights to reject any or all the bids/quotations, cancel the bid process without assigning any reason. Further University shall neither be liable for any action nor be under any obligation to inform the bidders of the ground for any of the above action.
- 22. Bids should be un-conditional. The conditional bids shall be summarily rejected.
- 23. The Bidder shall not modify the financial bid format in any manner. If financial bid submitted in any other format will be rated as non-responsive and not considered.
- 24. Contract will be awarded to total aggregate lowest bidder of all above said work.
- 25. EMD shall be forfeited at the sole discretion of CCSHAU in case tenderer after intimation from CCSHAU of the acceptance of his tender, either wholly or in part, refuses to accept the Work order/ or changes any of the conditions of the tender or changes the price/ or breach terms and conditions of the tender within validity period.
- 26. In the event of the failure of the FCA/Firm to fulfill its obligations duties as per contract CCSHAU, Hisar shall have right to recover from the security deposit the losses suffered due to such failure. The firm may also be debarred/blacklisted depending on severity of lapses.
- 27. The concerned FCA to whom work is allotted will be required to submit an Agreement on nonjudicial stamp paper of Rs. 100/- bearing terms and conditions of the contract within 21 days of the intimation of the acceptance of the allotment of contract, failing which bid will be rejected and EMD will be forfeited.
- 28. In the event of any dispute or difference arising out of or in any way touching or concerning the agreement whatsoever, the same shall be referred to the sole arbitration of the Vice-Chancellor or his nominee. The award of arbitrator shall be final & binding on the parties to this contract.
- 29. If the firm submits the Technical Bid/Financial Bid after the stipulated time, their bid is liable to be rejected.
- 30. If any of the information/documents furnished by the firm is found to be incorrect, the offer will automatically stand cancelled without entertaining any further correspondence.
- In case, work is not found satisfactory and breach of any of the terms and conditions of the contract, the contract shall be liable to be cancelled without notice.
