Remuneration shall be in the form of Honorarium on a case to case basis depending on the nature of work/work load as per extant rules in Government of Andhra Pradesh.

## 1. Venue & Deadline for submission of EoI:

Expression of Interest (EoI), complete in all respects as specified in the EOI, must be submitted to Crime Investigation, Department at the given address by the date & time specified above. In exceptional circumstances and at its discretion, the CID, EOW may extend the deadline for submission of response by issuing an amendment to be made available on the website, in which case all rights and obligations of CID and the applicants previously subject to the original deadline will thereafter be subject to the deadline as extended.

# 2. Instructions to Forensic Audit Consultants:

- 2.1 Last date and time for submission of EOI is **07.11.2024** (**1700 Hrs.**) which is also mentioned in the Text of Advertisement.
- 2.2 The Chartered Accountants/Forensic Audit Consultants may request a clarification on any clause of EOI document before the last date fixed for submission of EOI document.
- 3.3 At any time before submission of EOI, CID may amend the EOI Document by issuing an addendum in writing or by announcing. The addendum shall be binding on the consultants.
- 2.4 The Chartered Accountants/Forensic Audit Consultants are required to provide a professional, objective and impartial advice and strictly avoid conflicts with other assignments or their own corporate interests and act without any consideration for future work.
- 2.5 Without limitation on the generality of the foregoing, The Chartered Accountants/Forensic Audit Consultants and any of their affiliates having any conflict of interest, shall not be recruited.
- 2.6 The Chartered Accountants/Forensic Audit Consultants who have a business or family relationship with a member of the CID's staff who is

directly or indirectly involved in any part of the project shall not be considered for empanelment, unless the conflict stemming from this relationship has been resolved in a manner acceptable to the CID.

- 2.7 The Chartered Accountants/Forensic Audit Consultants have an obligation to disclose any situation of actual or potential conflict that impacts their capacity to serve the best interest of CID, or that may reasonably be perceived as having this effect. If the Chartered Accountants/Forensic Audit Consultants fails to disclose the said situations and if the CID comes to know about any such situation at any time in future, it may lead to the disqualification of them from empanelment.
- 2.8 The applicant shall bear all its costs associated with or relating to the preparation and submission of their EoI including but not limited to preparation, copying. # 3. Description of Services-Brief Purpose and Scope of Work:

#### 3.1 Purpose:

In connection with the investigation of a CID cases related to financial/economic offence, forensic auditing of the records for a period of 05 years is required to be conducted. The records include Annual Reports, Balance Sheets, Books of Accounts, Share Purchase Agreements, Share Holder Agreements, Valuation Reports, Assets Valuer Reports, Records related to Banks and other connected records. The scope of work may increase during examination of documents depending upon the investigation. Thus, the purpose is to assist the Investigating Officers/Court in explaining the various documents & its analysis by way of submitting a detailed Forensic Audit Report & deposing before the court as required from time to time.

### 3.2 Place of execution of the assignment:

To be conducted at the EOW, CID, AP, Mangalagiri.

- 3.3 The Forensic Auditor is broadly expected to:
- i. conduct forensic auditing of the financial records for a period of 05 years. The records include Annual Reports, Balance Sheets, Books of Accounts, Share Purchase Agreements, Share Holder Agreements, Valuation Reports, Assets Valuer Reports, Records related to Banks and other connected records. The scope of work may increase during the examination of the documents depending upon the investigation.
- ii. Any other work as mutually agreed upon to be included.

### 4. Qualification Criteria:

Following will be the minimum pre-qualification criteria. Each eligible Chartered Accountant/Forensic Audit Consultant should possess all the following pre-qualification criteria. Responses not meeting the minimum pre-qualification criteria will be summarily rejected and will not be evaluated.

#### 4. Pre-Qualification Criteria:

- i. The applicant shall be an Individual or partnership/sole proprietorship concern registered under relevant Indian laws & also registered with the institute of Chartered Accountants of India, New Delhi and who have their registered offices in India. (ICAI Certificate signed by the Authorized signatory)
- ii. The applicant should have relevant experience of at least 05 years as on date of release of advertisement in the field of forensic audit work. (Certificate by competent person/partner of the applicant's organization to be provided).

- iii. The applicant shall have experience of providing three similar completed Forensic Auditing services to Central Govt./State Govt./PSUs/Govt. certified bodies in India. (Details to be provided)
- iv. The applicant should have at least 03 full time Chartered Accountants and 02 Forensic Auditors on its pay rolls.
- v. The applicant should not be blacklisted by the Central Govt./State Govt./PSU/Govt. Bodies/Autonomous bodies.
- vi. Preference will be given to the applicant who is having prior experience of similar assignment for any Investigating Agency which has been completed satisfactorily and the expert's report has already been used as evidence in the court of law.
- vii. One applicant may apply for more than one proposal, however, CID will have the discretion to reject more than one work to one consultant to maintain quality as well as the time constraints.
- viii. Purchase Preference to Micro and Small Enterprises (MSEs), as per the Public Procurement Policy for MSEs vide Rule 1.10.4 of the MoI Manual for Procurement of Goods (Updated June, 2022) and as per provisions of latest Government orders on the subject.
