## (C) <u>Scope of work</u>

- 1. Preparation and e-Filing of TDS returns (24Q) of Central Railway Headquarter staff, in Electronic Format for the Financial Year 2025-26 including providing data for Form.no.16. of approx.3000 employees
  - a. The soft copy of the quarterly TDS data will be provided to the consultant. It should be ensured that the number of records and the amount of tax deducted should match with the number of records uploaded on the NSDL Website. Similarly, the amount of tax deducted / uploaded should tally with the amount of tax given by this office in the data furnished.
  - b. Rejection, if any occurring due to invalid PAN or any other reason should be immediately brought to the notice of the office. The pay group / Bill unit No. and the employee no. should invariably appear in the data.
  - c. All returns should be filed within the statutory due dates for each quarter for the financial year 2025-26.
  - d. E-Filing of Correction statements for the financial year 2025-26, as needed, also should be done promptly.
  - e. In case, default notice is received from Income tax department, for mistakes committed by service provider or delay in taking action on the part of the service provider, while filing returns or otherwise, then the interest and penalty, if any, levied by the department, on such occurrences shall be recovered from the service provider through their bills or security deposit.
  - f. Service provider has to reconcile the TDS deducted data with the books of Accounts of Railway, before uploading and filing of periodic returns. Any doubt regarding TDS data need to be got clarified from Railways before filing the returns.
