The Assam Food & Civil Supplies Corporation Ltd- AFCSCL is a Government of Assam undertaking incorporated under Companies Act, 2013. It has been set up for Procurement of Paddy and other agricultural product from farmers of Assam. The Key objective of the AFCSCL is to act as central procurement agency of agricultural product for the interest of farmers of Assam.

The Managing Director, HO Guwahati. Assam invites online Expression of Interest through Tender process for finalization of appointment of Tax Auditors from the reputed Chartered Accountant Firms with sufficient number of experience & qualified professionals for appointment of Tax auditor under two bid tendering system conducting Tax Audit (including consultancy) of the office of the Managing Director, AFCSCL located at 4<sup>th</sup> FLOOR, PARIBAHAN BHAWAN, KHANAPARA, GUWAHATI-781022 for the **Financial year 2024-25.** The Assignment may be extendable for maximum 2 years (One year at a time) on satisfactory performance of the work.

#### 2. Scope of Work

- i) To examine the books of accounts maintained by AFCSCL.
- ii) To carry out a tax audit of the Corporation as per applicable section of the IT Act, 1964 and submission of report thereon of the FY 2024-25.
- iii) To prepare computation of Income tax and e-filing of Income Tax return for FY 2024-25.
- iv) To revise of Income Tax return before the due date, if required for FY 2024-25.

#### 3. Assignment:

On selection of the Tax Auditor,

- (a) The work allotment shall be for one year i.e. FY 2024-25 and extendable for a maximum 2 years (one year at a time);
- (b) The works should carry out at the Corporation office & shall be completed before the due date of the Tax audit & return filling respectively.
- (c) The assignment shall be carried out by a team led by only CA.
- (d) Advisory on the Tax Matter.
- (e) Assistance in responding to notice or queries from Income Tax authority.
- (f) Verification of TDS, GST Compliance and Reconciliation.

### 4. Eligibility Criteria:

The eligibility criteria are as follows:

1	The Chartered Accountant firms must be empaneled with ICAI		
2	Registered and the head office of the CA firm must be in Guwahati.		
3	The CA firm should have experience in similar types of work for not less than a period of 10 (ten) years.		
4	The CA firm must have completed similar audit assignments in State/Central Government undertakings, Autonomous bodies and Public limited companies.		
5	The CA Firm should have a minimum Audited Annual Turnover of Rs.20 lakh in each financial year for the last three years.		
6	The CA Firm should have a minimum 5 (five) persons with sufficient qualifications and experience.		
7	The CA firm must be GST registered.		
8	The firm should not be blacklisted firm from any government agencies.		
9	The firm should not have disciplinary action initiated by ICAI at any time.		
10	Copies of appointment letters /audit completion certificates, etc from the audited

## 6. Selection procedure:

- (1) The selection shall be based on "Quality and Cost based Selection" (QCBS).
- (2) The weightage for the Quality is 70 (Seventy) and the weightage for the quoted price is 30 (thirty).
- (3) The Marks allotted against various sub-sections under quality are as follows:

- (4) The participating CA firm should appear before a discussion with the panel constituted by the Board and final marks given by them would be added immediately after the discussion. The CA firm should obtain a minimum of 25 marks from sl. 1 to 4 of above point no (3). The price bid shall be opened only to those qualified minimum of 50 marks.
- (5) Price bid shall be evaluated taking into account the price quoted for all services including GST (CGST & SGST) as applicable.
- (6) The evaluated Bid score (B) will be calculated which meets the minimum qualifying marks of 50 (fifty) in quality evaluation criteria, using the following formula:

#### $B = (C_{low}/C) \times 100 \times X + (T/T_{high}) \times 100 \times Y$

C = Evaluated bid price of the bidder

C<sub>low</sub> = The lowest of the evaluated bid prices among the responsive bids.

- T = The total marks obtained by the bidder against Quality criteria
- T<sub>high</sub> = The highest mark scored against Quality criteria among all responsive bids.
- X = 0.3 (the weightage for the quoted price is 30%)
- Y =0.7 (the weightage for quality is 70%)

Note:

- The evaluated bid score (B) shall be considered up to two decimal places.
- (a) The works shall be allotted to the bidder with the highest evaluated bid.
- (b) In the event of two or more bids having the same highest evaluated bid score (B), the bid scoring the highest marks against quality criteria will be recommended for the award of job. Even if there is a tie, the draw of lots will be resorted to arrive at the recommended bidder.
- (7) The decision of selection committee is final.

#### 7. SUBMISSION OF EOI

#### The Technical Bid shall include the following: -

- a. Submission of EOI must be online through https://assamtenders.gov.in portal, hard copy of EOI will not be accepted.
- b. All the Annexures & Appendices of MTF duly filled in and signed on each page by the Tenderer.
- c. List of documents attached as per the format inAppendix II, duly signed by the Tenderer.
- d. Tenders which do not comply with these instructions shall be summarily rejected.
- e. Tenders not accompanied by all the Schedules/Annexures intact and dulyfilled in and signed may be summarily rejected.
- f. It should be clearly understood by the Tenderer that no opportunity shall begiven to them to alter, modify or with-draw any offer at any stage after submission of the tender.
- g. Any attempt by tenderer to change the format of any of the supporting documents of the MTF while uploading or any attempt to tinker with the software of the portal will render his tender liable for cancellation and his subsequent blacklisting.

#### 8. Other Conditions:

- 1. The Corporation reserves the right to accept or reject the whole or any part of the EOI.
- 2. The selected Firm will have to execute the contract with the AFCSCL with immediate effect of the issuance of the letter of Award.
- 3. The Audit team will consist of a sufficient number of experienced and qualified professionals.
- 4. The selected firm will be required to comply with the instructions if any issued by the Corporation.
- 5. The successful applicant shall not be entitled to claim any additional amount for any reason whatsoever for the above audit work.
- 6. The job description and other terms and conditions may be supplemented or modified at any time by the corporation at its sole discretion and it shall be binding of the selected firm.
- 7. In case of any dispute, the decision of the AFCSCL shall be final and binding.
- 8. Submission of Report: Chartered Accountant Firm shall have to submit Tax Audit Report before the due date.
- 9. Regulation of Audit fees: The payment of Audit Fees as fixed will be made on satisfactory completion of the assignment. AFCSCL will not pay any advance to the selected audit firm under any circumstances. All taxes and fees are to be deducted or charged as per relevant laws in force and exclusion of GST which will be quoted separately, if any.
- 10. The auditors will not be provided with any special transport facility or accommodation, etc.
- 11. The AFCSCL reserves the right to accept or reject EOI without assigning any reason. The decision of the Selection Committee will be binding on the Firms/tenderers.

#### 9. Rate

Rate should be quoted by the bidders at price bid (BoQ) per month basis including GST. Note: Minimum fees for Internal Auditor is Rs.30,000/- per month exclusive GST.

#### 10. Payment Schedule:

The professional fee shall be paid after successful completion of the assignment and submission of authenticated copies of all requisite reports, forms and computations in soft and hard form.

#### 11. Performance Standards:

The firm undertakes to perform the services with the highest standards of professional and ethical competence and integrity and shall furnish its independent professional expert opinion. The firm shall ensure the completion of the assignment with utmost efficiency, discipline and punctuality.
