1. Scope of Work

 - o GSTR-9C
- · Providing consultancy on GST compliance, rules, notifications, and resolving GSTrelated queries raised by HPMC or Tax Authorities.

2. Eligibility Criteria

- The applicant must be a qualified Chartered Accountant or a firm registered with the Institute of Chartered Accountants of India (ICAI).
- Must have a minimum of 3 years' experience in GST filings and consultancy.
- Should have handled GST filings for at least two Government Organizations/PSUs/Corporate Entities.
- Must have a valid GSTIN and PAN.

4. Terms and Conditions

1. Responsibility for GST Return Filing

The selected CA/Agency shall be responsible for timely and accurate filing of GSTR-1, GSTR-3B, and GSTR-7 on a monthly basis and filing of GST-9 & GSTR-9C on annual basis.

2. Handling of Demand Notices

In case any demand/default notice is issued by the GST authorities after filing of returns, it shall be the sole responsibility of the CA/Agency to resolve such issues, without any additional cost to HPMC.

3. Data Submission & Consolidation

HPMC shall forward the required data in Excel format. The CA/Agency shall:

- Consolidate the data into the appropriate format for GST return filing.
- Share the formatted data with HPMC.

4. Review and Corrections

The CA/Agency shall verify the correctness of data before uploading. Any mismatches or errors shall be immediately brought to the notice of HPMC for clarification and rectification.

5. Rejection of Quotations

HPMC reserves the right to accept or reject any or all quotations without assigning any reason.

6. Payment Terms

Monthly charges shall be paid after submission of invoices and confirmation of return filing.

7. Period of Engagement

The engagement will be for **one year**, extendable based on performance and mutual agreement.
