Annexure - A

Award of contract for preparation & filing of Quarterly Returns of Income Tax deducted at source IT-TDS (Form-26Q) (Nonsalary Portion) for year 2024-25 & 2025-26 (Qtr-1)

A. Description of work:

(1) Filing of TDS original returns for statement 26Q in electronic format pertaining to all the four quarters of the financial year 2024-25 and first quarter of financial year 2025-26, including Consultancy services.

(2) Correction and filing of revised TDS returns of vendors/parties of previous

year/period, as and when such cases are observed/received/referred.

B. Period of completion:

1. All returns should be filed within the statutory due dates for each quarter for the financial year 2024-25 & first quarter of financial year 2025-26.

2. Correction and Filing of revised TDS returns for previuos year/period to be done

within 5 days from the date of submission of data thereof.

C. Scope of work

- (1) Preparation and filing of TDS returns statement 26Q to be done, for non-salary portion, on quarterly basis for the financial year 2024-25. Soft copy of data shall be submitted to the service provider on monthly basis. Service provider has to ensure that the number of records and amount of tax deducted matches with the number of records uploaded on NSDL website, during the filing of TDS 26Q statement. Similarly, the amount of tax deducetd as per the data furnished should tally with the tax amount uploaded. E-filing of TDS returns statement 26Q is to be done on quarterly basis.
- (2) Rejection(s), if any, occurring due to invalid PAN or any other reason(s) should be immediately brought to notice of this office by forwarding File Validating Utility Report and other relevant data/details thereof.
- (3) E-Filing of Correction statement for the financial year 2024-25 & first quarter of financial year 2025-26, as needed, also should be done promptly.
- (4) Correction and filing of revised TDS returns of vendors/parties of previous year/period, as and when such cases are referred, to be done promptly.
- (5) In case, default notice is received from Income tax department, for mistakes committed by service provider or delay in taking action on the part of the service provider, while filing the TDS returns, then the interest and penalty, if any, levied by the department, on such occurences shall be recovered from the service provider, through their bills or security deposit.
- (6) Service provider has to reconcile the TDS deducted data with the books of Accounts of Railway, before uploading and filing of periodic returns. Any doubt regarding TDS data need to be got clairified from Railway, before filing the returns.
