NOTICE INVITING TENDER FOR APPOINTMENT OF STATUTORY AUDITOR

Kudumbashree Broiler Farmers' Producer Company Ltd (KBFPCL), a company incorporated under the Companies Act, 2013 in 2019, now has a turnover of RS. 105 crores in the previous year, inviting **tenders** from eligible Chartered Accountant firms for appointment as **Statutory Auditor** of the company for a period of **five consecutive financial years** (2025–26 to 2029–30).

Scope of Work

- Conduct the statutory audit of the company's financial statements under the Companies Act, 2013.
- Conduct tax audit and file returns under Section 44AB of the Income Tax Act.

Eligibility Criteria

- The firm should have its head office in Thiruvananthapuram.
