1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
4. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

3. Audited balance sheet counter signed by C.A. for three years out of last four financial years clearly indicating turnover and T.D.S. Average financial turnover should be at least 50% of the estimated cost during the last three financial years out of last four financial years.

4. PAN and GST/IGST registration certificate.

5. The contract will generally be valid for three years at first instance. However, the same may be extended on mutual consent subject to the review of the performance during the contractual period and subsequent approval of the Competent Authority to a period as decided by the Competent Authority of GBU.

6. Never Black-listed affidavit : The vendor shall submit an affidavit (duly notarized) on Rs.10/- stamp paper as per below format (***the affidavit issues date/notarize date should not be earlier than the bid publish date***):

7. Sub-judice Matter Clause : The bid of the participating firm shall not be considered, If any matter of the bidder against the University is sub-judice in any Court of Law.
8. Notwithstanding anything contained in the draft, in case of any dispute, ambiguity and interpretation of any provisions of the draft, the decision of the Competent Authority of the GBU shall be final.

6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

Scope of Work:

1. Maintain subsidiary account books of the GBU in Tally software, including Journal, Ledger, Cash Book, Trial Balance, preparation of the Balance Sheet for statutory audit and 12A Audit. Any discrepancies identified by the firm should be promptly reported for rectification.
2. Provide GST consultancy services, including the timely filing of GST returns with the concerned department. Handle all GST scrutiny cases of GBU, including previous years, related to GST audit, correspondence, and appeals.
3. Offer TDS consultancy services, including the timely filing of E-TDS returns with the Income Tax Department. Only the filing fee will be charged, with no additional professional charges. The firm will also issue TDS Certificates (Form No. 16 & 16A) without extra charges.
4. Conduct monthly reconciliation of accounts with various banks and submit an account-wise Monthly Reconciliation Statement to GBU. A Monthly Review Meeting between the CA firm and GBU officers will be held during the last two days of each month.
5. Handle all scrutiny cases of GBU, including previous years, in the Income Tax Department related to Income Tax and TDS correspondence, including appeals. No separate professional charges will be paid for this service.
6. Ensure the deduction of TDS in cases where payments are made after clearance by the CA. The CA or its authorized representative must provide written confirmation at the GBU office.
7. Assign a full-time employee of the CA firm to work on-site at the GBU office during all working days, handling accounting tasks on Tally software.
8. Either party may terminate the contract by providing four months' prior written notice (before December) without assigning any reason or any compensation.
9. Maintain a register/record of object-wise Budget and Expenditure in accordance with the approved budget.
10. Prepare financial reports as required by the competent authority.
11. Provide reports on referred files.
12. Undertake any other assignments as directed by the Finance Department from time to time.
