BIDDING:

Bids are to be submitted in two parts i.e. Techno Commercial Bid & Price Bid.

1. Submission of Bids:

- 1.1. The offer is to be submitted in two parts. The first part "Part-I, Techno Commercial Offer", should contain the detailed technical and commercial terms of the offer, but should not contain the price. The second part "Part-II, Price Bid" should contain the price offered.
- 1.2. Both parts are to be submitted in the designated e-tender portal.
- 1.3. The offers may be submitted as per the tender schedule given at the end of this document.
- 1.4. The offer should be submitted strictly as per the terms & conditions laid down in the EOI document.

2. Techno Commercial Bid (Part - I):

- 2.1. Techno-commercial bid should be submitted only in the format as indicated in this Bid Document.
- 2.2. Self-attested copies of testimonials and documentary evidence in support of experience and other credentials for Evaluation are to be uploaded. Evaluation will be made on the basis of eligibility criteria.
- 2.3. Evaluation will be made based on eligibility criteria.

3. Price Bid (Part-II):

- 3.1. Price Bid should be submitted only in the format as indicated in this Bid Document as Annexure- 2.
- 3.2. Selection of the Consultant will be done on the basis of the i. e. L-1 price.
- 3.3. In no case the rate should exceed Rs. 2,500/- per case, irrespective of the number of invoices involved for a single case.
- 4. No Conditional offer will be accepted.

EVALUATION OF BID:

- 1. Award of contract will be made to the qualified applicant, who has offered the lowest price in the offer. This will be evaluated separately for the assignment mentioned above.
- 2. In case of a tie, the applicant with longer experience will be preferred based on the year of practice.
- 3. The decision of the Chairman, WBMSEFC shall be binding on all the participants.

PAYMENT TERMS:

Monthly payment will be made along with taxes and duties (as applicable) based onthe rate awarded, subject to fulfillment of other terms and conditions of the contract and a list of "deliverables".

OTHER TERMS AND CONDITIONS:

Disqualification:

The applicant would be disqualified while selection or during its ongoing work if:-

The chartered accountant shall defend, indemnify and hold during and after the term of the contract from any liabilities, damages, claims, fines, penalties, actions, proceedings and expenses of whatever nature arising and resulting from the non-compliance or violation of any law by him / her.
