ANNEXURE I: GENERAL TERMS & CONDITIONS

- 1. **The Chartered Accountant Firm**must start their work within 7 days from issue of work order.
- 2. **The rates (Basic Rate +GST)** if any as per instruction in the workorder. No extra charges will be entertained. Prices can be quoted in Indian Currency only (\mathbb{Z}) .
- 3. The quoted price would be valid upto 180 days from the submission date of the NIQ.
- 4. If any part of the service in respect of the work assigned and undertaken by you not rendered/delivered in time, Aliah University shall be entitled to levy and recover liquidated damages/ penalty at 1% per week or part thereof the delay/ default, subject to 5% maximum, on the payment due to the agency/contractor for the particular stage. Any delay beyond scheduled dates may attract higher penalty to be decided by the Aliah University
- 5. The bidder must know the accounting and finance policies of Government of West Bengal and also have the experience of Audit and Finalisation of Accounts of one or more State University.
- 6. The Chartered Accountant firm cannot outsource the work.
- 7. The information provided in the application by the Chartered Accountancy firm must be current, relevant and free from misstatements on the date of application.
- 8. The Authority is not bound to accept the lowest bid and reserves the right to accept or reject any or all responses and to request additional submissions or clarification from one or more applicant(s) at any stage or to cancel the process entirely at its sole discretion without assigning any reason whatsoever.
