1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.

15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

Buyer Added Text-Based ATC Clauses

1. Experience Requirement

The CA firms should have a minimum of three (3) years' experience in auditing private/government sector programmes/schemes and tax audits under Section 44AB of the Income Tax Act, 1961, with sufficient staff to carry out the task.

2. Preference

CA firms having prior experience of auditing accounts of missions in other departments will be given weightage.

Terms of Reference (TOR) for Statutory Audit

1. Consolidated Statements at SPD Level

Preparation of audited statements (consolidated) / audit reports (consolidated) at SPD Level for release of funds to universities and colleges as infrastructure grants and various components.

2. Preparatory Grant and MMER

Preparation of audited statements (consolidated) / audit reports (consolidated) at SPD Level for Preparatory Grant and MMER separately.

3. Verification of Records

Verification of maintenance of documents, photographs, asset register, stock register, cash books, NIT/NIQ, estimates, technical sanctions, bank account statements, interest accrued, etc., as per RUSA guidelines, and reporting the same in audit reports.

4. Compliance with Guidelines

Verification of compliance with component guidelines while planning, execution, and supervision of programmes, and reporting the same in audit reports.

5. Bank Reconciliation

Reconciliation of bank accounts with books of accounts maintained at the SPD level.

6. Component-Wise Reconciliation

Reconciliation of component-wise receipts and expenditures.

7. Fund Flow Mechanism

Verification of fund flow mechanism and time required for transfer of funds to vendors and Government accounts.

8. Classification of Entries

Identification of wrong classification of accounting entries (errors of commission/omission) and ensuring correction before closure of audit.

9. Central and State Share

Verification of release of Central Share and matching State Share as per programme guidelines.

12. Outstanding Advances

Identification of outstanding advances and inclusion in audit reports (with names of persons against whom advances are outstanding and duration).

13. Cash/Bank Balances

Analysis of cash balances, bank balances, and advances at the beginning and closure of the financial year.

14. Cash Withdrawals

As cash withdrawals from RUSA accounts are not permissible, identification of all cash withdrawals and preparation of a separate listing in the audit.

15. Grant-Wise Statement

Preparation of a separate statement for receipt and expenditure against grants received, grant-wise, clearly indicating sanction number and date.

16. Annual Statements as per C&AG Formats

Preparation of annual statements as per C&AG formats for SPD office.

17. Place of Audit

Audit must be carried out in the SPD office.

18. Discussion with Beneficiary Institutions
