- 1. - 2. 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

- 1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- 2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
- 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

4. Purchase Preference (Centre)

Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for percentage of 100% of total value.

5. Service & Support

7. Past Project Experience

Proof for Past Experience and Project Experience clause: For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. Contract copy along with Invoice(s) with self-certification by the bidder that service/supplies against the invoices have been executed.b. Execution certificate by client with contract value.c. - (ii) The Contract is for One year and the same may be extended to further One year bey ond expiry of the contract in force by Competent Authority of the ESIC Medical College & Hospital Indore upon mutual consent subject to satisfactory performance and same t erms & conditions and rates.
- (iii) Successful Firm/Agency shall arrange the visits of their representatives(CA) to ESIC Medical Co llege and Hospital, Nanda Magar, Indore at least twice a week during office hours and beyond office hours as per requirement of the office.
- (iv) Successful Firm/Agency shall provide the full details of their representative (Chartered Account ant) with qualification/address etc. who will visit the office for work.
- (v) Successful Firm/Agency shall send their representative (Chartered Accountant) with authorized Identity Card.
- (vi) No other charges will be paid separately except that quoted by the Firm/Agency in the financia
- (vii) Representative (Chartered Accountant) of the successful Firm/Agency shall be bound to maint ain office decorum of the ESIC Medical College and Hospital, Indore.
- (viii) Successful Firm/Agency shall keep the data of this office in safe and secured custody and shall be liable for any damage/loss/theft of data.
- (ix) The Competent Authority reserves the right to impose penalty of Rs. 500/-(Rs. Five Hundred O nly) per visit on the successful Firm/Agency, if representative remains absent for a week without a ny justified reason.
- (x) Successful Firm/Agency shall arrange for necessary software free of cost for the work assigned as per scope of work.
- (xi) Contract with Successful Firm/Agency shall be deemed to be withdrawn or cancelled without prior notice in case the Firm or any Partner of the Firm in discharge of his/her work has been deba rred by ICAI or by any regulatory Authority/Court.
- (xii) **CONFIDENTIALTY CLAUSE-**Successful Firm/Agency must ensure that no data pertaining to I T/GST of this office is leaked or disclosed to any other Firm or Individual failing which contact will be cancelled and the firm will be black listed by ESIC.
- (xiii) ESIC Medical College & Hospital, Indore will not provide any transport facility or accommodati on to the employees of the successful firm under any Conditions/ circumstances.
